108	Apologies Cllr Harper and Cllr P Hayward. Apologies accepted
109	Declarations of Interest Cllr S Bartlett –personal interest invoice for payment
110	Minutes The Minutes of the meeting held on the 15 th October 2019, having been previously circulated, were adopted as a true record. The Minutes of the Playfield Committee, of the same date were also accepted.
111	Matters Arising Cllr T Greenshields informed the meeting that no further information was available regarding the Rope Walk
112	Police Report A short report had been circulated prior to the meeting which was noted.
113	County and District Report Both the County and district councillors had submitted a written report, which were noted

115	Accounts for payment Resolved to pay the following accounts: Community Shop £21.30, S Bartlett £44.00, Salaries £164.82, Hawkchurch PCC £100.00, lottery (November) £75.00 and RBL Poppy Appeal £20.00
116	Financial Update The financial update had been circulated prior to the meeting and was agreed with the exception of the earmarked funds for the Solar Farm Fund which should read £16,194. An amended sheet will be issued.

117	Bank Reconciliation Total financial assets as at 16 th November 2019 was £40,583.82.
118	Section 106 Cllr Greenshields informed the meeting that a meeting had been arranged for the 26 th November at 10.30am in the Playfield.
119	Planning Applications a) 19/2316/Ful Patricks Bungalow, Hawkchurch. Demolition of outbuildings and construction of hobbies room together with wildlife pond in garden: Support b) 19/2462 & 3 Wyld Court: Replacement conservatory and raising of garage roof: Support c) 19/2175/Ful Hawkchurch Playing Field: 10m high emergency column topped with LED luminaries for use by Devon Air Ambulance night landing. As this is the council's application it was noted.
120	Determinations 19/1298/LBC Wyld Court: Change of use of outbuildings to accommodation and holiday use. This application has been refused by the planning authority
121	Highways and Rights of Way Concerns that the council had been unable to get hold of the Lengthsman to undertake some highway works. There are some works to be undertaken on bridleway 14. This is being arranged by the ROW department but charged to our P3 account.
122	Website Cllr Dr Nolan had provided a very impressive demonstration of the new website
123	Precept 2020 Resolved that the precept for 2020/21 remain at the present rate of £10,000. The budget would be £14,000.
